

Noble Dance Credit Card Agreement Form 24/25

The preferred payment method is credit card for all Noble Dance students enrolled in the 24/25 full season. Payments will be recurring through automatic charges. You ARE NOT bound to an entire season of dance with this agreement. If, for whatever reason, you decide to discontinue dance classes, *you must notify Miss Brandy in writing*, either by note in the tuition box or via email, otherwise auto payments will continue to occur.
